



## RELEASE FORM

**LIABILITY WAIVER AND RELEASE:** I am voluntarily entering or agreeing for my child to participate in the Golden Running Academy's practices, races, or other event(s), as well as activities related thereto (collectively, the "Event(s)"). I agree not to enter my child into any of the Events unless my child is medically able and properly trained. I agree to abide by any decision of a Golden Running Academy official or coach relative to my child's ability to safely complete any Event.

I recognize that my child's participation in the Events is a potentially hazardous activity and I willingly assume all risks for my child associated with such participation, including, but not limited to, falls; contact with other participants, spectators, or others; the effects of the weather, including heat, humidity, wind, cold, and wet or slippery surfaces; falling tree branches or other overhead objects; traffic; and the crowded nature and other conditions of race courses, all such risks being known and appreciated by me.

Having read this Release and knowing these facts, I, for my child and anyone entitled to act on his/her behalf, do hereby waive, release, discharge, hold harmless, and covenant not to sue the Golden Running Academy LLC and its associated consultants, from present and future claims and liabilities of any kind, known or unknown, arising out of my child's participation in the Events.

**MEDICAL AUTHORIZATION:** I grant the Golden Running Academy and its coaches permission to administer or arrange for any and all medical attention that they deem necessary or appropriate as a result of my child's participation in the Events, in the event that I cannot be reached, including without limitation, arranging transportation to a hospital or other medical facility. I also grant the Golden Running Academy access to my child's medical records and physicians, as well as other information, relating to medical care that may be administered to my child at any such medical facility as a result of my child's participation in the Events. I hereby assume the responsibility for the payment of any such treatment deemed necessary for my child.

**PUBLICITY RELEASE:** I grant permission to the Golden Running Academy to use or authorize others to use my child's photographs, motion pictures, videos, sound recordings, statements and/or any other record of my child's participation in the Events, including name, age, gender, race results, etc., for the purpose of promoting, advertising, marketing, training, website or other purposes for the Golden Running Academy.

**PAYMENT TERMS:** I understand that Team Dues must be paid within the 2<sup>nd</sup> week of joining the team and are prorated for the 1<sup>st</sup> month my child joins the team. I further understand that after the 1<sup>st</sup> month, ongoing monthly Team Dues are to be paid by the 25<sup>th</sup> of each month for the following month. I acknowledge that current Team Dues are priced at \$150/month for the competitive program, \$100/month for the development program, and a \$15 discount to these prices will be applied for each additional child.

**ACKNOWLEDGMENT OF UNDERSTANDING:** I have read this Release, and I fully understand its terms and conditions. I acknowledge that I am signing the Release freely and voluntarily, and that I intend by my signature to completely and unconditionally release the Golden Running Academy to the fullest extent allowed by law. I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Colorado and that this Release shall be governed by and interpreted by the laws of the State of Colorado. I agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release, which shall continue to remain in full force and effect. I agree that this release is effective as long as my child is a member of the Golden Running Academy.
